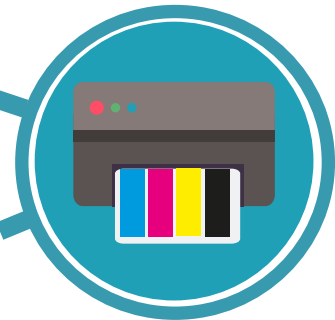
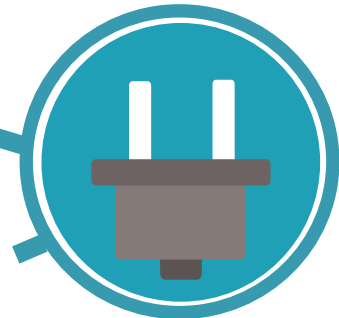


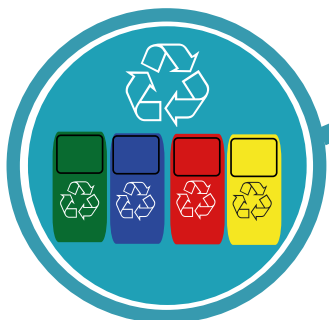

Paper

It's vital that we produce premium packaging without the worry of recycling repercussions. We are committed to protecting the environment through sustainably managed resources and this is reflected in how we run our business.

As we are an FSC® and PEFC certified producer, our customers have the opportunity to be a part of our sustainability Chain of Custody. This Chain of Custody promotes transparency through our responsibly sourced card. All of our carton board is recyclable, biodegradable and compostable.

Chemistry Free Plates

Printing plates are used to transfer an image to paper or other substances. Ink is applied to the image area of the plate and transferred directly to the paper. Typically this is achieved using photochemical processes.

Priory Press Packaging have made a significant and innovative investment to make our plating process completely chemistry and water free. Not only is this less harmful for the environment but it also provides greater image consistency for our customers.

All of our printing plates are also recycled after use.



Inks & Sealants

Vegetable - based inks

At Priory Press Packaging, we use vegetable-based inks. As opposed to traditional petroleum-based ink, vegetable-based inks are more environmentally friendly, may provide more accurate colours, and make it easier to recycle paper.

All of our sealers are water-based - products are sealed to encapsulate the inks, making them less susceptible to 'rubbing off. Water-based sealers are used instead of solvent-based products because they create a cleaner, safer environment for employees and customers; maintaining environmental air quality and reducing harmful fumes. Thanks to improving technology, many water-based sealants now outperform their solvent-based counterparts.



Foiling

Packaging that has been foiled can be recycled. Our foil supplier Foilco, researched the effects of foil when printed on paper, cartons and board. The findings indicate that the hot stamping foil content of the printed product, has no detrimental effect on the ability to recycle the packaging. The foil content of most printed items is less than the ink. Two independent studies were conducted to determine the biodegradability and the recyclability of foil stamped paper. Foil has no visible effects on slowing down the rate of biodegradation of the paper & board.

Window-Patching

We offer compostable window patch film that can be used by our customers on their packaging should they wish to do so.

UV Varnish / Spot

Packaging that has been finished with UV Varnish / Spot is not currently biodegradable.



Energy Resources

All of the energy used to power our machinery comes from renewable sources, namely wind power. Wind power consumes no fuel and emits no air pollution, unlike fossil fuel power sources.

We have signed a contract with 3T Power, ensuring all of the electricity we use is certified as renewable. Through the Carbon Trust, we have installed low LED lighting on our whole production floor, which is more energy efficient and less harmful to the environment. LED lighting has a longer lifespan than traditional bulbs and in some cases, can last up to 25 times longer.



Waste Management

We operate an internal waste recycling plan which has reduced our waste disposal costs significantly. All dry goods including paper, plastics, metal, cartons and laminated print are recycled.

We deliver used wooden pallets to a local recycling centre where they are converted to wood chip.

We also recycle office ink cartridges through The Recycling Factory who ensure the cartridges are recycled or disposed of in an ethical and environmentally friendly way.



Cycle to Work Scheme

At Priory Press Packaging, we operate the Northern Ireland Department of Transport's Cycle to Work scheme.

The initiative encourages employees to cycle to work reducing air pollution from cars, whilst also encouraging a healthy lifestyle. The incentive allows employees to obtain bicycles tax-free.
